The management of Maynilad Water Services, Inc. and the officers of the Maynilad Water Supervisors Association (MWSA) have successfully negotiated the unresolved provisions of the Collective Bargaining Agreement 2009-2010, which covers the company's 240 supervisors.

Appearing today (February 5) before the National Conciliation and Mediation Board (NCMB), the two parties reached a mutually beneficial arrangement that will allow the water company to proceed with its daily operations without any threat of work disruption.

Maynilad would like to thank the public and its stakeholders for their continued support during the CBA negotiations.
