

DE LOS SANTOS MEDICAL CENTER SIGNS CBA

MANILA, Philippines, 9th September 2013 – De Los Santos Medical Center Inc. (DLSMC) , a Quezon City based hospital which 51% equity holding was acquired middle this year by Metro Pacific Investment Corporation concluded the renewal of a 3 year Collective Bargaining Agreement (CBA) with its employees' Union yesterday, September 9.

The Medical Center was founded by the late Dr. Jose V. De Los Santos Sr. considered the father of Philippine Orthopedics. DLSMC is a level 3 teaching and training hospital along E. Rodriguez Avenue in Quezon City with an authorized capacity of 150 beds.

DLSMC is the 7th Hospital of the MPIC Hospital Group which also includes Makati Medical Center, Asian Hospital in Alabang, Muntinlupa , Cardinal Santos Medical Center in San Juan, Our Lady of Lourdes Hospital in Sta. Mesa , Riverside Medical Center in Bacolod and Davao Doctors Hospital in Mindanao.
